RE: Reflections and Preparations for Student Success during OnTECH's Winter Quarter

Dear OnTECH Parents,

We are very excited start our Winter Quarter this coming Monday, December 3rd!

The OnTECH staff have been reflecting upon the growth we have witnessed this fall, and we are carefully planning the changes necessary to help our students become even more successful this winter. To this end, we will be implementing two very specific changes starting Monday, regarding cell phones and student laptops.

Student Laptops:

We are excited to be able to loan individual laptops to our students for their use for school. This is a privilege and requires that students are responsible and careful with the laptops at all time. Beginning Monday morning, students will be asked to report to the main office to sign out their individual laptops, to be used for the day, and will return them only during lunch and at the end of the day before busses are dismissed. This change is important for two reasons:

- 1. This allows our students to build personal agency (responsibility) skills necessary for the work environment.
- 2. This eliminates the time needed to sign laptops in and out during each class, extending the amount of time available for learning.

Student Cell Phones:

Starting this Monday, we will be requiring all students to *not* have their cell phones with them while in class. It has not only been our experience that phones are distracting, but research being conducted across the country teaches us that during the adolescent stage of brain development excessive phone usage can be unhealthy because phones distract from learning, contribute to mental health issues including social anxiety and undermine essential sleep patterns. Help us help your children address these issues.

To eliminate the distractions of phones, we will be requiring all students to adopt **one** of three pathways:

- 1. **Pathway 1:** Students will provide their phone to administration, while signing out their individual laptop. Phones will be kept locked in the laptop cart, in the slot dedicated to the individual student's laptop. When laptops are returned during lunch, and at the end of the day, phones will be returned and may be used.
- 2. **Pathway 2:** Parents may choose to keep a student's phone at home, rather than allow it at school. Should the student be found to have both the OnTECH laptop and a cell phone during class, the laptop will be returned and parents will be called for a meeting to discuss phone use with the student. Laptop access will not be restored until such a meeting takes place; however assignments are still expected to be completed.
- 3. **Pathway 3:** Parents may indicate that the student does not own or have access to a cell phone. Should a student be found in possession of both a phone and laptop, the parent will be called for a meeting. Laptop access will not be restored until such a meeting takes place; however assignments are still expected to be completed.



We greatly appreciate your help as we determine the best methods for teaching our students to be fluent with technology while minimizing the disadvantages associated with the digital age in which their brains are developing. This approach to cell phones will help our students become successful at managing their responsibilities in school, college and in employment.
